3) The following tests are to be applicable for each size of the valves as individual

product certification.

- Hydrostatic test of the valve body at a pressure equal to 1.5 times the design pressure - Cryogenic testing consisting of valve operation and leakage verification for a minimum of 10% of each type and size of valve for valves

- Proving testing at ambient temperature consisting of leakage test at a pressure equal to 1.1 times the design pressure

1) The product is to be permanently marked with manufacturer name and type designation on a suitable position.
